## General Release of All Claims and Waiver of Liability and Indemnity Agreement

In consideration of the mutual promises and covenants contained herein and the recitals hereto which are contractual and an integral part of this release and waiver of liability and indemnity agreement, the County and the Releasor (hereinafter collectively referred to as the "Parties") hereby agree as follows:

1. For and in consideration of Releasor being permitted to use the \_\_\_\_\_ Community Garden owned by Gwinnett County Board of Commissioners, Releasor does hereby for Releasor and Releasor's heirs, executors, administrators, successors, and assigns, now and forever, fully and finally, RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the County and each and every of the County's agents, officers, and employees, from any and all claims and demands, whatsoever in law or in equity, and from any and all actions and causes of action, damages, claims for injuries, both known and unknown, including future developments thereof, cost, business losses, expense and compensation on account of, or in any way growing out of any and all known and unknown personal injuries and property damage resulting or to result from the use of said property.

2. Releasor hereby expressly stipulates and agrees, in consideration of the use of said property, to indemnify and hold harmless the County, and each and every of the County's agents, officers, and employees and all others directly or indirectly liable to any other person, firm or corporation charged with responsibility or person, firm or corporation charged with responsibility or liability, their heirs, administrators, executors, successors and assigns, with respect to any additional sum of money that any of them may hereinafter be compelled to pay on account of the injuries to Releasor. Releasor further agrees to reimburse and make good to the County any loss, damages or costs the County may have to pay as a result of any such action, claim or demand.

3. This Release contains the entire agreement between the Parties. No promise, inducement, or representation other than herein set forth has been made, and the terms of this Release are contractual and not a mere recital. It is further agreed that the undersigned have fully and completely read this Release in its entirety, and that each signed it as their own free act.

## Garden Guidelines and Permits

This is an annual agreement for a plot at the garden, valid through March 31, 2027. A completed application is required in addition to a non-refundable, nontransferable plot fee of \$35. Plots are assigned on a first-come, first-served basis after payment is received. Plot fee includes the use of land, utilities, shared tools, compost, and mulch, if available. Any fees levied on the garden by the bank for a renter's returned check must be reimbursed to Live Healthy Gwinnett.

The garden is operated as a sustainable garden. Any chemicals and materials used must be on the Approved Materials List located at [LiveHealthyGwinnett.com](https://LiveHealthyGwinnett.com).

Access codes will be given to enter the Community Garden. Admittance hours are in accordance with Gwinnett Parks and Recreation, sunrise to sunset. Always lock the gate and reset numbers on combination locks upon exiting the garden. To help maintain proper security do not share the access code with non-approved gardeners.

To keep common areas and share rows maintained, all gardeners agree to participate in 12 hours of community service per year.

Adhere to all Gwinnett County [ordinances](#). Respect fellow gardeners always. Offensive and/or profane language and any discrimination against others are prohibited.

Pets are permitted inside the garden if they are leashed, controlled, and show no aggression. Pets cannot be near other plots, and any waste must be disposed of by the owner immediately. If found to repeatedly leave waste unattended, lease privileges will be forfeited for the remainder of the lease term. If the pet owner is a visitor, they will no longer be allowed access to the garden. To keep the garden safe and clean, please prepare and address pets' needs before entering the garden and immediately pick up and dispose of any waste. Pets are not allowed to consume any material, plants, or other vegetation in or around the garden. Owners are responsible for appropriate control and behavior of their pets. General park laws and ordinances regarding pets apply.

Children/guests are welcome at the garden but must be accompanied by plot holder who is responsible for the guest's behavior. Any activity inconsistent with gardening shall not be allowed and may result in loss of gardening privileges.

A neat, attractive, cared-for appearance garden plot is required. Once assigned, a plot shall be properly maintained within 30 days. Plots will be kept planted, watered, harvested, weeded, mulched, and free of dead plant material (other than compost.) They must be properly maintained all year long and not left in fallow or unused condition, remaining free of weeds, pests, and diseases. Nothing may be dumped in the surrounding natural areas around the garden perimeter.

Be mindful of planting sprawling or tall crops that might interfere with other plots, if they extend beyond the assigned plot or interfere with other plots they may be cut back to the proper boundaries by Live Healthy Gwinnett. Do not plant illegal or poisonous plants. Live Healthy Gwinnett will retain the right to decide whether a plant is appropriate for the garden. If a plot becomes neglected, every effort will be taken to notify the plot renter.

If plot continues to be neglected for 30 continuous days, the plot will transfer to a new caretaker. A refund may or may not be granted because of a plot loss. A refund may be granted if the plot loss occurs within the first two months of ownership. Any produce from the reverted plot will be harvested for donation. If you can no longer take care of your plot, either temporarily or indefinitely, and cannot decide on plot upkeep, please notify [HarvestGwinnett@GwinnettCounty.com](mailto:HarvestGwinnett@GwinnettCounty.com).

Harvest only from your assigned plot. Gardeners harvesting from other plots without permission will lose gardening privileges in addition to any other remedies available by law.

Place all compostable materials in designated compost areas and non-compost waste in waste containers. Plots should be properly mulched and water conservation is required. The soil, compost and mulch material from the bin area is property of the garden and may not be removed.

All hoses must be turned off after use and recoiled to their designated areas. Keep hoses orderly: Do not leave knots, kinks, or debris in or on the hose. Please do not tug or forcefully pull the hose, hose reel or water spigot. An issue with a hose caused by mismanagement and mishandling may cause loss of water access for an undetermined amount of time. Please immediately report any issues or problematic conditions with water hoses and/or spigots to **678.277.0287** and/or **Bradley.Livesay@GwinnettCounty.com**. *If there is a site emergency (i.e., water line break), immediately call 770.827.4753.*

There is no guarantee protection against vandalism or theft. Any vandalism or theft should be reported to Live Healthy Gwinnett. Any items left at the plot are at the plot renters' own risk and will be deemed abandoned at the conclusion of the permit term. Be aware of your surroundings always. Bring a "garden buddy" as often as possible.
